## End of Year School Reporting Arrangements

There is no current government guidance in relation to reports to parents during Covid-19. We know that Multi-Academy Trusts will have their own response to this; so this is our optional guidance for maintained schools. We would support a report to parents that covers the period that the child has been in school. The nature of this report may look very different from school to school and the level of detail will also depend on individual circumstances. We would see this as something that could be realistically achieved and then communicated to parents/carers through electronic means by the end of the summer term.



#### NQTs – DfE Guidance for induction assessments

DfE have today issued induction guidance for NQTs related to the current situation. It includes the following statements.

We will be making regulatory changes that, subject to parliamentary agreement, will mean that NQTs absent for reasons related to the current COVID-19 public health emergency will not have their induction period automatically extended.

If there are concerns that a NQT has not achieved the standards by the and carers with learning at home for children end of their induction period, we would strongly encourage headteachers and appropriate bodies to exercise their discretion to recommend an extension, allowing the NQT further time and opportunity to demonstrate their ability to meet the standards.

## DfE Free School Meals Voucher Scheme

We have become aware that some schools have yet to receive an email from Edenred. We are limited in our scope to support schools with this, as the national voucher scheme has been developed by the DfE. However, there are some suggestions in terms of why you may not have received an email that you could look at, if you then still are not receiving anything, you will need to call the DfE helpline. In some schools the email has gone to the 'Junk boxes,' so please check this as a first point. Secondly, there may be issues with emails being blocked, which would be a matter for your IT provider to work through with you. We are always committed to supporting schools, but we are limited on the National Voucher Scheme I am afraid, we do ask that queries in relation to this specific scheme, if unresolved, are directed to the DfE.

It is right that schools concentrate their effort and resources on those who are eligible for benefits-related free school meals at this time. There is no requirement to continue to provide universal infant free school meals to pupils in reception, year 1, or year 2 who are unable to attend school. Children in those year groups who are eligible for benefits-related free school meals will be supported though.



### **Attendance Registers**

You will have seen the guidance from the DfE that you should continue to submit your daily online attendance form throughout the Easter holidays, we did raise this with the Regional Schools' Commissioner as a point around our responsibility in relation to manageability for our schools in a climate where you are already going above and beyond to support a local area approach.

If pupils are attending you own onsite provision then the online register should be straightforward in terms of both completion and submission.

If you are a school that is hosting an Easter provision for other schools and your staff are available to complete the register, then we ask that they record on the register as appropriate and then send to the DfE securely.

Where the Easter provision is from an external provider and school staff will not be available to take a daily register, we ask for a safe, common sense approach be applied. We would ask that the provider collects a daily attendance register, which they will be doing anyway and that copies of the register are then left with the school. As and when school staff are able to collect the attendance register, this can then be collated and uploaded to the DfE, with us accepting that this may not be immediate.

For schools that are closed during this time, we ask that you send a daily nil return through but if you are working with another school locally, offer any support you can, if they need help with uploading data and information.

As a Local Authority we see that the offer of provision at this important time comes first and will accept that your different circumstances will dictate the speed in which you are able to upload attendance to the central site.

## **Updating your Safeguarding Policy**

Government guidance was published on 27th March regarding safeguarding in schools, colleges and other providers. Full details can be found <u>here.</u>

'Schools and colleges will have an effective child protection policy in place reflecting business as usual. It is likely that the policy will not accurately reflect new arrangements in response to COVID-19. It is important schools and colleges (led by a DSL or deputy, wherever possible) review and revise their child protection policy and keep it under review as circumstances continue to evolve. In some cases, a COVID-19 annex/addendum that summaries any key COVID-19 related changes might be more effective that re-writing and re-issuing the whole policy.'

The LA has provided a useful addendum that you can use to ensure your school policies comply with the DfE guidance. This was emailed to schools on 31<sup>st</sup> March.

### Finance Update – Invoicing Protocols

During the current pandemic situation, many schools may now be closed or operating with low staff levels. This may mean that the task of arranging payment of invoices will become more difficult to do in a safe and controlled way for those staff charged with administration. Internal audit have highlighted that virtually every school they have visited over the last few years operates a process where the electronic purchase order on the Civica system is raised at the point when the invoice has already been received, this negating any control function that the electronic order might offer. Some schools operate manual orders or requisition documents for budget holders/head teachers to sign to authorise the purchase of goods and services, this will be difficult to achieve at the moment.

What the majority of schools have in common is that they rely on the authorisation of the invoice by the Head/Budget Holder as a key control. The Finance person in the school office will physically print the invoice, apply a GRED (goods received) stamp and will seek out a wet ink signature to authorise the invoice for payment. This is the catch all control if controls at the point of ordering the goods are not effective. Many schools have highlighted that they are unable to obtain this wet signature from the Head/budget Holder. The payments function of the council are now accepting emailed invoices with just the GRED number and PO number type onto the invoice (using a typewriter function they have told us is available). This solves the process issue but places administrators at risk as there is no additional person involved in the process.

Please find below an interim procedure for schools to follow to address this shortfall in control:

#### Invoices over £400

For every invoice that they forward to the council for payment over £400 there should be an email from the Head confirming:

- the amount of the invoice
- a brief detail of the supply
- that they authorise the spend
- the invoice number quoted
- The associated purchase order number

The email should be stored by the business manager on a school drive electronically with an electronic copy of the invoice.

#### Invoices below £400

All orders below £400 should be collated on a cover sheet (this could be done on excel with amount, description of goods, date of invoice, date of order, PO number, GRED number) on a fortnightly basis (or when the number of orders exceeds 150 whichever is sooner) the cover sheet should be sent to the Head for him/her to check through and confirm they have checked what has been ordered for appropriateness. An email should be sent back to the Business Manager confirming this check. As a back up check, Head Teachers should also check budget monitors from Civica on a monthly basis. We were hoping to roll out new guidance around electronic ordering but this has been paused due to the current emergency arrangements
